# REGULATIONS RELATING TO THE AWARD OF THE SCHOLARSHIPS KNOWN AS PANJAB UNIVERSITY SOLDIER'S RELIEF FUND SCHOLARSHIP.

- Two scholarships will be awarded every year to the sons & daughters of members of.
   Defence service studying at the Panjab University Department/College, preference will be given to the children of those who are disabled or have been killed in Millitary operations.
- 2. Each scholarship shall be of the value of Rs. 400/-p.m. for 10 months
- The tenure of the scholarship shall for the duration of course to which a student is admitted, i.e. two or three years as the case may be.
- No students shall be hold a scholarship under these regulations alongwith another scholarship without the approval of the Vice-chancellor
- 5. A student who has been awarded scholarship under these regulations shall be liable to pay the tuition fee to the deptt./college for the months for which the scholarship is claimed. This, however, shall not debar him/her from grant of full or half fee concession by the deptt./college.
- 6. Scholarship shall be awarded to the express understanding that the holder shall attend the deptt./college as a regular student & pursue his/her studies with industriously if it should appear at any time that scholars fail to make satisfactory progress or has been guilty in gross misconduct/attendance, he shall after due warning, be reported by the Chairman/Principal of University/Deptt./College to the Vice-Chancellor who may diminish or withdraw the scholarship.
- A scholarship shall be awarded by the Vice-Chancellor on the recommendations of a committee to be appointed by him.
