First detected in the Chinese city of Wuhan during December 2019, this virus has infected more than 22,00,000 people across 210 countries globally. Out of those infected, more than 152,000 people have died and more than 56000 people are critically ill. As a strategy to contain potentially infected people and prevent the virus from spreading further, in many parts of the world, borders are closed, businesses, airports, hotels are shut, school and universities cancelled. Entire countries are being placed under quarantine for safety measures and people are in panic and so are the governments. These unprecedented measures are disrupting many economies, resulting in mass job losses and raising the unemployment. Supportive fiscal, monetary and public health measures and policies can help to restore confidence but cannot offset the immediate disruptions that result from enforced shutdowns and travel restrictions.

There are also signs that it will permanently change the way the society functions. From its impact on the global economy to our daily lives, COVID-19 will leave an enormous impact on how we work, how we learn, how we consume and how we socialize and communicate. This has to be a difficult time for people with poorrelationships or those struggling with behaviours such as alcoholism and gambling. Similarly, people who have mental illnesses, such as depression would be most affected. Amid COVID-19, the individual are being forced to surrender basic civil liberties in return for security, which alters the social contract in the liberal world. By promising security, authoritarians may exploit COVID-19 as a pretext to further contract the public space and enjoy more powers to intervene into private lives.

At the political front anti-establishment politics created by inequality in recent years will intensify. Over the past many years, public anger at traditional political elites has upended politics in many countries. That anger is driven in part by suspicion that political establishments in these countries aren't able to meet the needs of those who've benefited the least from globalization and technological change over the past generation. Then, other issue is which nation will emerge as world super power and world leader after covid-19 political shocks and how the political equations will change, across and between nations. These political consequences can be profound and impossible to predict.

While it is too early to determine the long term impact of this crisis, but this crisis will trigger drastic changes at economic social and political front. In this scenario, there is a need to discuss how the world will be affected by this public health emergency and what could be the possible economic, social and political transformation that the world will undergo in near future. Therefore, UBS, Ludhiana has thought of providing a platform to the researchers, academicians and practitioners across the world to come forward and discus these sissues.
